In addition to the Members, the European Commission Unit for EU Integration of People with Disabilities, DG Employment, Social Affairs and Equal Opportunities received **Observer Status** with ENAT in 2008. This status was continued in 2009 and 2010, and transferred to European Commission Unit for EU Integration of People with Disabilities, DG JUSTICE in 2011.

Of the 150 Associate Members, 71 were from Sweden. 69 of the Swedish members were ENAT Associate Members under <u>the group membership agreements</u> with the national *Access Sweden*.

The group membership agreement is available to any national or regional organisation that wishes to enrol its members in ENAT. In addition to the membership fee, an annual lump sum is paid as a subscription fee covering all the members, thus saving money for the individual subscriber and giving the full benefits of ENAT membership to each member. This subscription scheme is therefore recommended for national NGOs and larger membership organisations.

A large majority of ENAT Members are private businesses. Others include public authorities, publicly-owned attractions, social cooperatives, foundations, national and international non-governmental organisations, education and training institutes and providers of consultancy and other professional services.

2. ENAT Strategy and Activities

2.1 ENAT Strategy and Workplan 2010 to 2014

The activities conducted by ENAT in 2011 were a continuation of the 2010 – 2014 Draft Workplan, which was provisionally approved in 2010.

The ENAT Strategy and Workplan 2011 to 2014 was discussed at the ENAT Board Meeting in Brussels on 18 May 2011 and updated during the course of 2011.

2.2 Network Activities

2.2.1 ENAT National Co-ordinators' Activities

Main activities of National Coordinators and Board Members are listed below. (See also Section 4, "**Events**").

- Angelika Laburda attended international and EU events, speaking and representing ENAT.

2.3 ENAT Fund-raising, Sponsorship and Recruitment

The sources of funding for the ENAT association are:

- Membership fees
- Sponsorship and donations
- Income from consulting work conducted by members on behalf of the association
- Project funding.

In 2011 membership fees and project income contributed to ENAT's budget.

The ENAT Financial Report 2011 is shown in a separate document.

Plans for fund-raising are included in the draft ENAT Strategy and Workplan 2012 – 2014.

2.4 Recruitment

One of the key functions of ENAT is to act as a point of reference, not only for its members, but also for organisations around the world that are working towards a common vision of accessible tourism for all. The ENAT Board considers proposals for Honorary Membership to be given to persons and organisations that share ENAT's objectives and can make a positive contribution to carrying out ENAT's mission.

No Honorary Members were nominated or appointed in 2011.

2.4.1 Open Call for New National Coordinators

The Open Call for new national coordinators, published in summer 2008 remained open in 2010, at:

In order to ensure that National Coordinators have the support of members in their country or region, the ENAT Board decided in 2009 that new Coordinators (candidates) should, as a matter of principle, seek the support of their peers through a fair and democratic ballot of all ENAT members in their country or region. The arrangement of this procedure would be left to the members themselves to carry out.

Furthermore, it was decided by the ENAT Board that the Board will only confirm the status of a National Coordinator AFTER such a ballot has been reported to the Board, confirming that support is given to the winning candidate. In exceptional circumstances, on the recommendation of the ENAT members in a given country or region, the ENAT Board may decide to appoint more than one ENAT National Coordinator.

2.4.2 ENAT Contact Points

In 2011 the ENAT Secretariat received requests by a number of ENAT members to act as *"National Contact Points"*. These persons have volunteered to take on responsibilities including answering enquiries and ENAT network-building in their respective countries, language areas or regions:

- 1. ENAT Member Margareta Tokarska, Accessible Poland Tours as ENAT Contact Point for Poland
- 2. ENAT Member Veroniek Maat, Accessible Travel Netherlands as ENAT Contact Point for The Netherlands
- 3. ENAT Member Kazuist as ENAT Contact Point for Czech Republic
- 4. ENAT Member Ahmed El Rida as ENAT Contact Point for Libya
- 5. ENAT Member Ibrahim Abu-Helil, Jordan, as ENAT Representative to the Arab Tourism Organisation and the Middle East North Africa Region.

These members were given administrative approval by the ENAT Secretariat, based on their record of active networking in their countries/regions/sectors.

2.4.3 Full Membership Candidates

Several Associate Members made a formal request to become Full ENAT Members in 2010-11.

3. ENAT Publicity and Outreach

3.1 ENAT Web Portal Development

In 2011 the ENAT portal continued to provide the features and services which were developed in 2006 - 2008 by EWORX S.A. Some additional (back-office) features and improvements were implemented in connection with upgrades of the "TOOLIP" Web Content Management System (CMS).

A Facebook webpage (<u>https://www.facebook.com/accessibletourism</u>) a Twitter page (<u>http://twitter.com/#!/EUaccesstourism</u>, and a <u>LinkedIn Accessible Tourism Group</u>

were maintained in 2011 order to spread the name of ENAT and report our activities more widely. Facebook followers in 2011 : 400

Twitter followers in 2011 : about 120 LinkedIn Group Members in 2011: about 75.

3.1.1 Regional websites

The ENAT portal appears in English, French and Greek editions. During 2010 the English ENAT site was updated regularly; on average at least once a week. The French and Greek editions were updated less frequently. These latter editions need a more active editorial policy and more regular updating.

3.1.2 e-Bulletin

A semi-automated emailing system, adopted in 2009 (<u>www.mailchimp.com</u>), continued in use in 2011.

This system allows e-Bulletins to be distributed via direct emailing to ENAT Members and stakeholders. Using Mailchimp, content is aggregated in an email containing links to original articles on the ENAT website. The system monitors how many recipients open their emails and which links are 'clicked'. This has proved useful for eliminating non-active emails and identifying what kind of content is most likely to be read. The system is free of charge for lists of less than 2,000 subscribers.

During 2011 ENAT sent 7 e-Bulletins to about 900 subscribers.

Bulletins were opened on average by 26 – 30% of subscribers (which is about 10% above the industry average for NGOs, according to Mailchimp).

The main English web pages numbered over 1245 items (unique articles) by the end of 2011, with about 170 pages added since the end of 2010.

As reported in previous years, "passive" usage of the website (*i.e. reading and downloading documents*) is fairly strong. However, "active" usage (*ENAT members adding their own content*) is still very weak. The Website CMS allows ENAT Members to upload their own content using pre-loaded templates but this has only been used very rarely by National Coordinators and a few Associate Members.

The web pages also allow ENAT members to post <u>Comments</u> on published items. However, this function is also hardly used. ENAT articles that are linked to Social Media sites (Facebook, Twitter and LinkedIn) generate many more "likes" and user comments.


Web search: "Accessible Tourism"

3.2.2 ENAT Code of Good Conduct Commitment Label

The ENAT Code of Good Conduct, launched in 2009, has been signed by about 60 ENAT Members.

Businesses and organisations that sign up to the Code receive a commitment label and certificate recognising their efforts to promote accessible travel and tourism.

- The ENAT Code of Good Conduct is the first and only international labelling scheme for the promotion of ethical business standards in Accessible Tourism for All.
- The Code consists of 8 guiding principles which businesses and organisations follow, so as to make travel and tourism accessible for all visitors who experience access difficulties. These customers may need better access and services due to disability, long-standing health problems, age-related conditions or other temporary or permanent personal conditions which restrict their access.
- The guiding principles of the Code are based on the objectives of ENAT, (as contained in the <u>Association's statutes</u>), and also on sound and ethical business practices which enhance accessibility, sustainability and the quality of customer service.

5. Working Groups and Projects

5.1 ENAT Policy Group

During 2010, a number of issues related to ENAT's policies for accessible tourism development were taken up in discussions by the ENAT Board and Board Members, and with several outside parties.

- Members of ENAT led workshops, conference sessions and gave presentations on numerous subjects related to accessible tourism policy throughout the year.
- ENAT (Ivor Ambrose, Cléon Angelo (ANLH) and Kathleen Polders (ENTER vzw.) participated in activities of the CEN-AENOR Working Group on EC Mandate 420 "Accessibility Standards for the Built Environment, concluding in September 2011. The Final Report of Phase 1 was (finally) approved by the Commission on 12th April 2012.

5.3 ENAT - CEN Workshop Agreement on Accessible Tourism Services

In December 2010 CEN organised a Seminar on Tourism Standards where ENAT was invited to present its views and proposals for a CEN Workshop Agreement.

Further meetings were held with CEN and the European Commission in 2011. The draft title of the activity was changed to <u>"Universal Design of Accessible Tourism Services</u>" and a revised CWA Business Plan was circulated to the Commission and CEN for discussion. As a result, EC financial support is foreseen for this action in 2012.

5.4 ENAT Business Support

5.4.1 ENAT Code of Good Conduct for Accessible Tourism

The ENAT Code of Good Conduct and labelling scheme has been conceived as a way for enterprises and organisations to show, publicly, their commitment to a set of accessible tourism principles.

eAccess + The project was funded and commenced on 1st October 2010 for 3 years. The project is led by the University of Linz, Austria. <u>http://www.eaccessplus.eu/</u> **ENAT** - as a partner of eAccess+, takes on the responsibility of engaging with the Travel and Tourism sector, working with its organisations and stakeholders to increase knowledge and share good practices in three main areas:

- Development of accessible websites and e-solutions for the tourism and travel industry
- Accessible convergent communications and accessible digital audio-visual systems for use in the tourism sector
- Self-service terminals (SSTs) and mobile devices for banking and financial services, public transport, tourism and cultural heritage.

'eAccessibility' aims to ensure that everyone is included and is able to use e-Services. By establishing the new eAccess+ network ENAT wants to support the opportunity to eliminate barriers for tourists with a disability to participate and use tourism facilities.

5.6 UNWTO – ENAT – F.ONCE Collaboration Agreement

The collaboration agreement signed in September 2011 has initially established 4 projects, to be implemented from 2011 - 2015 (4 years). These are:

- 1. Update of UNWTO 2005 Resolution on accessible tourism for all
- Accessible Tourism Manual for NTOs and Best Practices Collection (2 books)

 by a restricted call for tender
- 3. Accessible Tourism Business Case by a call to Business Colleges for a study using the Harvard Business Case methodology.
- 4. Insertion of disabled employees/trainees in UNWTO and tourism labour market, to be developed with FUNDOSA Group (ONCE) partners.

Additional projects can be introduced.

A Joint Commission has been established to establish specific agreements for each project and monitor progress. The members of the Joint Commission are:

5.7 New Project Proposals

In autumn 2011 ENAT joined a proposal with the International Social Tourism Organisation (ISTO-ISTO) and others to provide a <u>Web Platform for cross-border</u> <u>Social Tourism in Europe.</u>

The "STEEP" (*Social Tourism European Exchange Portal*) proposal was accepted by European Commission's DG Enterprise Tourism Unit and work will start on 1st April 2012, lasting 15 months. Several ENAT Board Members will work on the project, ensuring that accessibility and disability issues are fully addressed.
